Florida Real Estate License: Broker As a condition of licensure, brokers must successfully complete a 72-Hour Pre Licensure Course based on the FREC II syllabus and pass the required end of course exam. Applicants must take and pass the broker licensing examination within 24 months of course completion.

Completing the Course. To successfully complete the Florida 63 Hour Sales Associate Pre-License Course, you must pass a 100 question exam at the end of the course. 70% is passing (70 correct). If you do not pass the first time, you will have to wait 30 days before retesting.
