Workplace Procedures – Key Elements Employee screening procedures - prior to work Temperature, self monitoring symptoms (Cough, fever, shortness of breath) Require employees to report symptoms and self-isolate Notify supervisors and stay home Don't allow employees to return until home isolation criteria is met (Follow CDC Guidance)
