In New Hampshire, a standard second-offense DWI is a Class A misdemeanor. There's a mandatory 30-day jail sentence for offenders with a prior within the past two years and a mandatory five-day sentence for motorists with a prior conviction that preceded the present conviction by more than two but less than ten years.

There are two basic ways that a driver can be guilty of DWI in New Hampshire: First, if the driver is operating a motor vehicle on a public way while under the influence (defined as "impaired to any degree") of alcohol, a controlled drug, a prescription drug, an over the counter drug, or any other substance; Second, if the driver's blood alcohol content is .08 or greater (.02 or greater if the driver is under the age of 21).
