Proof of Address Letter & Proof of Address Documents

Board member's name, full residential address and date of issue should appear on the document to be acceptable. Utility bills and bank statements should be not older than 3 months. Certified translation into English is required for any documents that are not in English, Estonian or Russian.

Documents that can be used as proof of address and ...

Most banks will accept a bank statement as proof of address, provided it's recent. The general period for relevance is three months. Statements are typically accepted from banks, credit unions and building societies. Credit card statements, provided they're recent, are also generally considered a legitimate option.

TSA will require a federally compliant driver license, identification card or another acceptable form of identification (such as a US passport or military ID) to fly within the U.S. Compliant DL-ID Card. The proof of residency letter, also known as an ' affidavit of residence ', is a sworn statement that a person resides at an address. This is often required by a Department of Motor Vehicles (DMV) when getting a drivers license or applying for street parking.

The name and address on the document must be the same as it appears on the application for title a post office box or business address is not acceptable. Street Sections 322.051 and 322.08, Florida Statutes, require that applicants provide proof of residential address documents to obtain a Florida driver license or identification card. Two documents from the approved documents list on the back of this document are required.
